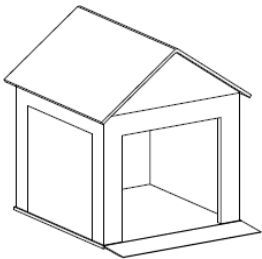

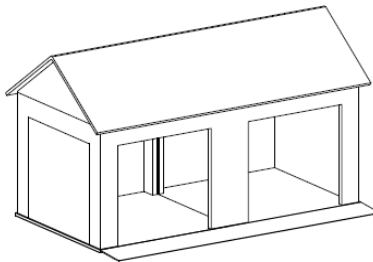

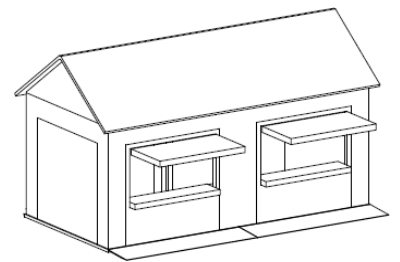
Single Walk-In
